day isolation and no longer have symptoms, masks must be worn at all times outside of home for an additional five days.

Employees must mask in all indoor work settings, except while alone in work stations.

Masks are still required in places that implement the Restrictions Exemption Program.

Faster response times achieved by Edson Fire Department

The average response time for members of the Edson fire department has decreased from 9 minutes to 6 minutes, representing a 33% faster response time, since the implementation of the green light program.

Fire Chief Tyler Robinson said that while the faster response time was not the goal of the program, "It has worked very well. It has allowed our responders safe and open travel to the fire station. It didn't take very long to educate the public. Even pedestrians, if they see that green light a block away, they wait and allow our people to get by." The result has been a positive impact on department response times allowing the responders to get to an emergency sooner.

Chief Robinson reported the 2021 Edson Fire Department statistics to Town Council at their regular meeting on Tuesday evening.

The local fire department saw a 10.7% increase in calls in 2021 compared to 2020 responding to a total of 411 calls (up from 167 in 2020). Fire department members logged 22,198 person hours, or the equivalent of 11 full time positions, in the past year. Those hours include weekend on call hours, response times, and training hours. The volunteer firefighters do receive an honorarium, but Robinson said most municipalities would consider the Edson fire department a volunteer fire department.

A significant increase in medical first response calls and outside fire calls has been noticed by the department since 2019.

44% (or 166) of the department's calls were Medical First Response (MFR) in 2019. By 2021 that number had increased to 50% as 206 of last year's 411 calls were for medical first response. Of those 119 were not drug related, 34 were undetermined, and 53 were overdose or drug related calls.



Chief Robinson said while the undetermined and non-drug related call numbers remain reasonably consistent year over year, "The drug and overdose calls is the concern area." In 2019 the department responded to 17 of those calls; by 2021 that number had more than tripled to 53. "There has been an obvious spike in the drug related overdoses in the last three years. Many are repeat patients as well as fatalities unfortunately," said Robinson.

The Edson fire department responds to all 911 "Delta" or "Echo" calls- those which are life and death. Those members within the department who wish to respond to medical emergency calls take part in monthly training sessions to ensure they maintain their level one first response qualifications. The department also responds to "Charlie" medical emergency calls - when an ambulance will be delayed for more than 15 minutes - in order to stabilize the patient prior to the arrival of EMS.

"Not all members are trained to that level," said Chief Robinson, "But the ones we send on those calls are." Robinson said the department recognizes that responding to life and death medical emergencies is not for everyone and the department respects those decisions, "We are ensuring that the members who want to respond to those calls are trained."

Chief Robinson told Council that the department has a good working relationship with the local EMS. AHS has been supportive of the program and has even supplied some necessary equipment for the department.

The calls to outside fires increased from 6 in 2019 to 25 last year. 21 of those calls were caused by the vulnerable sector. Chief Robinson said

those calls "have really spiked" and the trend is concerning as it represents a 200% increase in vulnerable sector calls over the three-year period. Most of the calls were to fires in the trails or at non-authorized temporary shelters and all were within town limits.

Councillor Moore congratulated Chief Robinson on the faster response times. Moore then, referencing one of the graphics in the presentation, asked if the department still rescues cats from trees. Although responding to "cat in tree calls" may not his first choice; Chief Robinson responded, "If it's your emergency that's our emergency..."

Town Council Highlights for January 18, 2022

Land Use Bylaw Amendment. Council has given first reading of Bylaw 2270, Land Use Bylaw Amendment. This bylaw provides clear direction, certainty, and efficiency when it comes to excavation, stripping, or grading in the Town of Edson. A public hearing will be held February 15th. More details on the proposed bylaw can be found at www.edson.ca/bylaws.

Cemeteries Bylaw: Council has given all three readings to Bylaw 2272, the Cemeteries Bylaw. The changes are meant to better align the bylaw with current operational needs, update definitions, and add disinterment guidelines.

Budget Adjustment: \$30,000 was approved to be transferred from the Revenue Sharing

Reserve to the 2022 Cemetery Budget for the purpose of columbarium repairs and mitigation of damaged cremains. This follows the discovery of a water penetration issue. Affected families have been notified and consulted on this process.

Edson Eagles Requests: Approval was granted for Administration to adjust the existing facility rental payment terms with the Edson Eagles Jr. A Hockey Club. The new terms require payment a minimum of one month in advance. A request for an exclusive locker room space was denied at this time.

Provincial Budget Consultations: Council has approved a written submission to be sent to the province regarding their budget consultations. This correspondence will include five priorities: infrastructure and stable funding for municipalities, homelessness, downloading services/expenses to the municipal level, policing, and funding for healthcare.

Personnel Matter: Council approved the terms discussed in camera regarding a personnel matter.

Next meetings: The next Council meeting is scheduled for February 1, 2022, at 7:00 pm. The next Committee of the Whole meeting is February 8, 2022, at 7:00 pm. While the Council Chambers remains closed to the public at this time, public and media are able to register for virtual attendance for regular Council and Committee Meetings. 

The standard fine for Distracted Driving in Alberta is \$300 and three demerit points. So we can assume that Minister Madu also received the appropriate demerit penalty.

But is that where the unfortunate lap judgement on the minister's part ended?

Nope.

It took an even more serious turn when Justice Minister Madu decided to call the Edmonton Police Chief, Dale McFee, directly about the ticket

It is critical to any democracy that the line between government political offices, and the administration of justice never gets crossed.

It is completely unacceptable for Alberta's Justice Minister to initiate a phone call to the Police Chief regarding a traffic violation charge against him, no matter what other topics were discussed during the call.

Chief McFee stated that Madu never asked to get out of the ticket. But the point is, even the perceived conflict of interest, or perceived pressure by initiating the call, is crossing the critical line that separates government and the independence of law enforcement.

"Regular Alberta drivers do not have the ability to call

their local police chief and discuss traffic tickets. Madu used his position as minister to initiate this conversation, and regardless of whether he asked the chief to cancel the ticket, it is political interference for him to have discussed it all," the NDP stated in a news release.

Sgt. Mike Elliott, president of the Edmonton Police Association posted, "The audacity and arrogance is very clear and you are not deserving to be Minister of Justice who is suppose to represent all citizens in a fair and impartial manner."

Madu stated he regrets calling the police chief after the ticket had been issued. He also promptly paid the ticket in full.

As a result of the phone call, (and, little doubt, the added media and public attention) Premier Jason Kenney recently asked Justice Minister Madu to step back from his ministerial duties until an independent review into his conduct can be completed.

With Madu apparently choosing not to resign, it looks like a drawn-out process to decide his fate is the path that lays ahead for the UCP government. But questions remain, including why is this only coming out now after 10 months and who else in the government may have known?

County's Enforcement sees 450 investigations in 2021; new drone aids in situational awareness at incidents

At the January 19 Governance & Priorities Committee Meeting, Yellowhead County's Director of Protective Services Albert Bahri presented a 2021 Year End Report to Council.

Bahri said the report was "a basic overview of some highlights" of what his department had accomplished in 2021, which he described as "a busy year."

The report started with Emergency Management, stating that both Emergency Operations Centres (EOC) are fully functional and in a state of readiness. The EOC was activated twice in 2021, once for the Lobstick fire and then again for the train derailment in

The County has also set up new Fire Detection

Cameras which are already providing coverage, and DroneSense is up and running for situational awareness at incidents.

Yellowhead County's EOC Management Staff have also been named to the North Central Regional Emergency Management Team, and the Municipal Emergency Plan (MEP) was approved by Council after being inspected and approved by the Alberta Emergency Management Agency (AEMA).

Regarding Enforcement, the report noted that the department is fully staffed with eight team members, and the staff hired this year come from "a variety of enforcement backgrounds" including fish and wildlife, rural county/farming familiarity, and post secondary institutions.

From an Enforcement Operations standpoint, the County saw 450 investigations, with the bulk of complaints regarding animal issues followed

by property-related issues. The County also took care of 40 property cleanups, all of which were Municipal Government Act (MGA) orders.

924 violation tickets were issued in 2021, along with 450 written warnings. The department also executed nine provincial warrants.

64 summons were issued, with 19 of those for speeds greater than 50km/hr over the limit, 1 for failure to remain at the scene of an accident, 17 for operating on a highway without insurance. and 8 for operating a vehicle while suspended.

E-ticketing was implemented in April which has led to faster traffic stops, which the report notes is "safer for everyone." There are also less errors on tickets, and they are easier to read for both the courts and accused. The system will later integrate into the administrative penalties system that is being introduced by the Government of Alberta.

Enforcement staff have also been increasing the patrol of the County's own properties and facilities to deter theft and to reduce issues of liability for the County.

The report noted that non-essential training in the department was reduced due to COVID, but two staff did attend and complete emergency vehicle operations training. The department also participated in 12 joint enforcement operations with other agencies, mainly the RCMP.

In addition, "We have increased our presence at emergency scenes which has greatly assisted in the security of those incidents with the added benefit of an increase in detection of individuals driving at excessive speeds past our fire

Elk River Substation Telecommunications Tower Replacement

AltaLink has determined that an upgrade is required to the existing telecommunications tower at the Elk River Substation in NW-1-46-14-W5M, located in Yellowhead County. The existing telecommunications tower has reached the end of its life and is proposed to be replaced as part of AltaLink's ongoing maintenance program. The new telecommunications tower will be located within the existing substation fenceline; no fenceline expansion is required.


Telecommunications towers support the equipment that transmits data to our system control centre. This allows us to monitor the operation of the electric system and ensure the safety and reliability of the system for our customers.

The proposed new telecommunications tower will:

- be 36 metres tall (including the antennas and lightning rod)
- be a self-supported steel structure
- have a triangular base with each side measuring approximately 1.5 metres
- comply with Transport Canada's requirements regarding painting and lighting

personnel," read the report. "On top of assisting at emergency situations, peace officers licensed to operate the County's drone assisted with the search of a drowned individual on the McLeod River and also assisted the Transportation Safety Board with aerial documentation of the downed helicopter at the Lobstick fire."

The Fire Services department saw 517 incidents in 2021, which included 1 aircraft emergency, 67 alarms, 21 electrical hazards, 222 MVCs, 15 mutual aid calls, 107 outside fires/smoke/wildland, 23 structure fires, 32 vehicle fires, and 5 technical/water rescues.

The Fire Services training grounds had a new burn structure and burn system installed, and while COVID made training in 2021 "very sporadic" the department did complete some courses including a 2021 Recruit/Cadet

In 2022, the main focus of the Training Division will be "going back to the basics and building the muscle memory back into the members," read the report. "This will include Structural Firefighting, Vehicle Extrication, Wildland Firefighting, Basic Pump Operations, and Vehicle Fires."

Under Dispatch, the report noted "2021 has been a year of progress and change." A new primary center was established and a secondary center in Evansburg has proven to be a viable back up while the primary was being

Currently, YRECC dispatches for 20 Peace Officer agencies and in 2021 brought aboard the City of Wetaskiwin for 911 and fire dispatching. YRECC is also currently talking with two municipalities that have shown interest in moving their 911 call taking/dispatching over and the department "hopes that these talks lead to a contract."

Regarding Information Technology (IT), the new Brule Tower (YH14) has completed their technology build out. The department also completed the implementation of a Service Desk ticketing software for Information Technology and extended its use to Facilities to keep track of repairs, requests, and projects.

The tower network infrastructure has also allowed the County to provide water treatment plants, fire halls, and other municipal buildings with shared network access on the County network. "[This] helped us to reduce monthly costs by sharing ISP services and terminating unneeded services," read the

Most tower sites also saw the implementation of fire detection and surveillance cameras to help protect assets and warn forestry of possible

Director Bahri noted that a new IT Manager will be starting with the department at the beginning of April 2022, which he said "will be a great

Finally, the Safety department noted that it successfully completed a Core Audit and review of their current safety plan is underway. They also have ongoing joint health and safety meetings.

The Protective Services Department's Year End 2021 Report was accepted as information by Council.

Edson RCMP charge two males for theft of truck

Edson RCMP: On Jan. 17, 2022, at approximately 2:35 a.m., Edson RCMP members observed a vehicle driving on Edson drive with no tail lights illuminated. A traffic stop was conducted on the vehicle. Officers learned that neither the driver or passenger were the owner and they could not produce any valid documentation for the vehicle.

The vehicle was towed and the two suspects were released from the scene after the driver was issued three traffic tickets for driving without holding an operator's licence, driving an uninsured motor vehicle, and for the tail light infraction.

As a result of the ongoing investigation Edson RCMP confirmed, with the owner, that the truck had been stolen. Both the

Immunocompromised Albertans eligible for fourth dose

(AB) January 18, 2022: More than 80,000 Albertans will soon be able to receive fourth doses of COVID-19 vaccine to bolster immunity.

In line with recommendations from the National Advisory Committee on Immunization (NACI) and the Alberta Advisory Committee on Immunization (AACI), individuals aged 18 and older who have specific immunocompromising conditions can receive a booster five months after receiving their third dose.

Beginning Jan. 20, eligible individuals can book appointments for fourth doses online with AHS and participating pharmacies by using the Alberta vaccine booking system or by calling 811

is to continue getting whatever dose we are eligible for. I encourage all Albertans to continue to sign up for their booster doses as soon as they can." —Jason Copping, Minister of Health

"Individuals with certain immunocompromising conditions can benefit from a fourth COVID-19 vaccine dose. With the rapid spread of the Omicron variant, we want to provide these Albertans with additional protection against the virus." —Dr. Deena Hinshaw, chief medical officer of health

Oualifying conditions

Immunocompromising conditions that qualify adults aged 18 and older for a fourth dose at least five months after a third dose include:

- · Transplant recipients, including solid organ transplants and hematopoietic stem cell transplants.
- · Individuals with malignant hematologic disorders and non-hematologic malignant solid tumors prior to receiving or receiving active treatment (chemotherapy, targeted therapies, immunotherapy or having received previous COVID-19 vaccines while on active treatment), excluding individuals receiving solely hormonal therapy, radiation therapy or a surgical intervention.
- · Individuals being treated with an anti-CD20 monoclonal antibody such as Rituximab.
- · Individuals with chronic kidney disease on

dialysis.

- · Recipients of chimeric antigen receptor (CAR)-T-cell therapy.
- · Individuals with moderate to severe primary immunodeficiency (e.g., DiGeorge syndrome, Wiskott-Aldrich syndrome).
- · Individuals with Stage 3 or advanced HIV infection and those with acquired COVID-19 immunization.
- · Individuals undergoing immunosuppressive therapies (e.g., anti-B cell therapies, high-dose systemic corticosteroids, alkylating agents, antimetabolites, or tumornecrosis factor (TNF) inhibitors and other biologic agents).
- · Individuals on certain medications for autoimmune diseases, including rituximab, ocrelizumab and ofatumumab.

Youth ages 12 to 17 with the preceding conditions continue to be eligible for third doses. Fourth doses have not yet been approved for this age group.

Third doses have not been approved for youth under the age of 18.

Appointments for additional doses

Eligible Albertans can book appointments online for AHS or participating pharmacies by using the one-stop booking system at alberta.ca/vaccine. Albertans can also book an appointment by calling 811 or participating pharmacies.

More than 8M vaccine doses administered

(AB) January 14, 2022: More than eight million doses of COVID-19 vaccine have been administered since December 2020, providing Albertans with critical protection against infection.

This includes 89.7 per cent of Albertans aged 12 and older who have received one dose, 85.7 per cent aged 12 and older who have received two doses, and 158,000 children aged five to 11 who have received their first dose of pediatric vaccine.

With the arrival of the Omicron variant, and increased booster eligibility for all Albertans aged 18 and older, vaccine demand has surged. Since Dec. 7, thanks to the widespread availability through Alberta Health Services and community pharmacies, more than 1.2 million third doses have been administered.

All Albertans are encouraged to get whichever dose of vaccine they are eligible for in order to further protect themselves and keep Alberta's health-care system from being overwhelmed.

"I am proud that AHS and pharmacies have responded to the increased demand for vaccine by quickly and safely delivering doses to the Albertans who need them. Vaccines are an important part of our efforts to prevent hospitals and ICUs from being overwhelmed with new cases of COVID-19, so it is critical that every Albertan continues to get each dose they are eligible for." -Jason Copping, Minister of Health

Book your vaccine

Based on current evidence, it

appears that vaccine effectiveness against COVID-19 infection wanes over time, particularly with the Omicron variant. Individual protection against severe outcomes remains strong after two doses for most, however, a third dose strengthens protection against both infection and severe outcomes.

Everyone 18 years and older can book appointments for a booster dose of mRNA vaccine at least five months after receiving their second dose. Albertans 12 years and older who are immunocompromised can also book an appointment for a booster but must wait at least eight weeks after their second dose.

First and second doses continue to be available across the province. Book online with Alberta Health Services and participating pharmacies by using the Alberta vaccine booking system. Albertans can also call 811or participating pharmacies.

Edson RCMP investigate fatal single vehicle rollover collision

On Jan.14, 2022, at approximately 1:45 p.m., Edson RCMP, RCMP Forensic Collision Reconstruction, Yellowhead County Fire Department, Yellowhead County Peace Officers and EMS responded to a report of a single vehicle rollover collision on Highway 16 near Range Road 150, east of Edson.

The preliminary investigation indicates a GMC Sierra pickup truck was travelling westbound on Highway 16 and lost control after a silver or grey older model SUV passed it. The truck entered into the median where it rolled before coming to rest.

The passenger was ejected from the vehicle. Witnesses stopped to assist and started CPR on the passenger until emergency services arrived. The passenger was flown by STARS air ambulance to a hospital in Edmonton where; tragically, the 28-year-old female, from the Edson area, later succumbed to her injuries and was pronounced deceased. The name of the deceased will not be released.

The male driver, a 48-yearold male, from Yellowhead County was transported by EMS to an area hospital for minor injuries.

The Edson RCMP and RCMP Forensic Collision Reconstruction continue to investigate this collision and want to speak with the occupant(s) of the reported grey or silver SUV.

Healthcare professionals call for action



Health Sciences Association of Alberta (HSAA) President, Mike Parker is asking for three things to help ensure health care is there for Albertans in the fifth wave and beyond.

(HSAA) Health Sciences Association of Alberta professionals have been, and always will be, there when Albertans need care. But the current government needs to help. This past week there were 266 unfilled paramedic shifts and three labs in Edmonton are closed indefinitely due to there not being enough staff. There are over 1000 health care vacancies in Alberta, and steps must be taken to support the health-care professionals we do have.

"When you or a loved one need emergency care, we are there to answer the call for help," began HSAA President, Mike Parker. "From the team of emergency communications officers who answer the call, assess the situation, and dispatch ambulances – the paramedics rushing

to give life-saving aid and get patients to hospitals – the people at the hospital that conduct and interpret tests – the highly skilled scientists in the labs – and the full range of therapists who treat and help with a patient's recovery... these are our members.

"No matter what we've encountered, healthcare professionals will always be there for Albertans, but after two incredibly stressful pandemic years, many are struggling to keep going. They need help from this government so they can continue to provide us care."

HSAA is asking government for three things:

- 1. Protect the physical health of health-care professionals. This includes more than just agreements to provide appropriate PPE N95 masks must get to all those who work on the front lines of health care.
- 2. Protect the mental health of all health-care professionals. We will continue to be here for Albertans as long as we can. But we need a partner that will live up to its agreements and show compassion to make sure we can do that. Specifically, they need to get days off, have an appropriate workload and not face punishment if they can not come into work.
- 3. A plan to retain and recruit health-care professionals. Ensuring that we don't lose more health-care professionals to mental or physical illness with the measures above is a good start. But there are over 1000 vacancies, we need to keep the ones we have. The first step is government showing them they are appreciated while providing the supports they need to stay on the job. Alberta also needs a plan to keep our current professionals and to take whatever steps are necessary to attract new recruits from around the globe to fill vacancies.

"HSAA members know who they work for...

all Albertans," continued Parker. "All we want is to be there when people need care. To do it our members need to be rested, they need to know they and their families are safe and that they are supported."

Understanding canola basis can give clues to what's happening in the market

'Canola producers, particularly those with canola in storage, follow canola cash prices,' says Neil Blue, provincial crops market analyst with Alberta Agriculture, Forestry and Rural Economic Development. 'However, not all canola producers track the difference between the cash price and the futures price for canola. That difference is termed "basis". Following basis can give clues of what is happening in the market and provide pricing opportunity.'

The basis is found by subtracting the futures price from a cash price. For example, in this historically strong canola market, one canola buyer's March delivery cash price is \$1028/tonne. The March canola futures is at \$1021/tonne. Cash price of \$1028 minus futures price of \$1021 equals +\$7/tonne March basis.

'Sometimes this is referred to as an "over" basis, specifically \$7 over the March futures,' explains Blue. 'Other buyers set their basis level according to how aggressively they need to attract delivery commitments from producers. When considering a basis quote, it is important to know which futures month is being referred to. Note that all buyers will not necessarily reference the same futures month for their basis quote for a specific delivery month.'

To analyze basis, one should know some basis history for that commodity. For canola, basis levels range from a weak minus \$80 (or cash price \$80/tonne discount to a futures price) to a strong plus \$80 (or cash price \$80/tonne premium to a futures price). Canola basis levels can even be outside of this range.

'Recent marketing year basis levels are also relevant to current basis analysis, and so are seasonal basis trends. Basis is a reflection of "local" supply and demand in a market, so canola basis levels tend to be weakest at harvest when there is usually plenty of supply relative to demand. As the marketing year progresses, supplies tend to tighten relative to demand and that situation often results in stronger basis levels into spring. This year, with drought-reduced canola supplies and strong vegoil prices, price and basis volatility tend to be high.'


Blue points out canola trade is a margin business, so buyers will only pay high enough to obtain needed supplies. Lately, as canola futures prices have risen to new highs, many buyers have weakened their nearby basis levels.

'That may indicate that buyers are closer to contracting their near-term needs or perhaps just not passing on the entire higher futures price in their cash bids. However, the deferred old crop basis levels have not changed much.'

With the futures market in a strong inverse with higher futures for nearby months relative to deferred months, buyers are applying a stronger basis to the deferred old crop delivery months to keep those cash prices competitive with nearby cash prices.

'For producers holding on to some canola waiting for an even more spectacular price, here is a strategy to consider,' says Blue. 'Like last year, as time passes to the next canola futures month, those prices have risen to approach the previous futures month's high. If that trend continues, consider contracting some of the stronger basis level for a later old crop month and leave the futures aspect of price open.

If that deferred futures price rises as time passes and buyers also weaken those basis levels, you can take advantage of the higher futures price with your basis locked in at a stronger level. There are cautions. First, know the deadline that the buyer sets for pricing the basis contract against the futures. Second, ensure that your canola will remain in good condition during storage; and third, in this high priced canola market, almost anything can happen,' says Blue. -AgriNews
